**NOTE: THE SHOW WILL NOT START AND WILL BE PAUSED IF ANY SPECTATOR, DRIVER OR PIT CREW MEMBER IS STANDING ON THE TRACK OR NEAR BARRICADES!  
THIS WILL BE SEVERELY ENFORCED**

### General Rules — All Classes

- All cars must pass a safety inspection and comply with official's decision; unobserved items escaping detection during inspection does not make them legal.
- All drivers must complete entry form as instructed.
- Seatbelts, helmets, and proper clothing required.
- All vehicles **MUST** have car number painted on roof or visible on a roof sign.
- Drivers are responsible for the actions of their crew members.
- Any driver and/or crew members not obeying rules or exhibiting conduct deemed inappropriate will be disqualified and be asked to leave the grounds.
- No profanity allowed on cars — this is a family event.
- Demo drivers will receive a pass to the grandstands and pit access for themselves and ONE other person. Additional passes for pit access may be available (see below)
- All drivers will attend a drivers meeting held 30 minutes before event.
- This is NOT a pin to win derby.
- Trophies will only be provided for first and second place finishes.
- **All decisions of officials are be final.**

### Entry

- **PARK YOUR TRAILER PRIOR TO REGISTERING!** Please do not park in pathways or leave vehicles unattended when properly parked.
- All drivers will show a valid form of ID, that shows proof of age.
- Entry fee for all classes is \$50.00 and all registrations are notarized.
- All drivers will attend a drivers meeting held 30 minutes before event.

## Pit Access

- For the safety of all fairgoers, pit access is highly restrictive and you must have a wristband to remain in the pit area.
- Demo drivers will receive a pass to the grandstands and pit access for themselves and ONE other person. You may purchase *two* additional grandstand & pit access wristbands.
- Wristbands are non-transferable.

**GATE ADMISSION PAYMENT IS REQUIRED FOR EVERYONE**

### Stock Chain & Bang Class

*4 & 6 Cylinder Front Wheel Drive Only*

***Payout: \$1,500.00 (split possible if enough cars)***

- Strip car clean.
- Bumpers must be stock type compact bumper; no welding, bolted only.
- Stock tires only — not trailer, truck, farm, etc.
- Hood, doors, trunk — chained or wired at two places each. Hood must be open for inspection.
- May move gas tank and battery.
- May use stacks.
- Crossbar behind seat, door to door only.
- This is a stock class — keep it clean.

### Compact Modified — Front or Rear Wheel Drive

***Payout: \$1,000 to win / \$250 second | Open to any mass produced 4 or 6 cylinder car or station wagon***

- Strip cars clean.
- Any tire allowed.
- Weld doors and trunk.
- Bolt hood at 4 spots after inspection.
- Allowed up to three (3) 4x6 plates per rail which may include plate holding bumper to frame, not the sub; no tying together.
- Body bolts 5/8" max.
- 4-point cage — halo bar, front and rear window bar, body to body, not to the frame. Nothing to the floor.

- Solid suspension ok — no welding to the frame!

## **Mini Vans & Small SUVs (Junk Run)**

*Payout: \$750 first / \$250 second | Follow modified rules above | All-wheel drive allowed | No full size trucks*

### **V8 Modified**

***Payout: \$1,500 first / \$500 second (minimum 6 cars required for full purse)***
