Contestant **MUST** not be a former title holder in this age division.

This contest will consist solely of a 3 minute prepared speech focusing on yourself, your future plans or goals, a person whom you consider to be a role model in your life as well as your involvement within your community as well as your favorite experiences at the Fair. We ask that you learn some history about the Broome County Fair any year of your choosing . You should wear a nice party dress or summer dress. **NO** evening gowns or, short formals please. You will be asked a few questions by our panel of judges following your speech, the history of the Broome County Fair. Judging will be based on poise, personality, speaking ability and overall appearance while on stage. The judges Decision is final.

The winner of this year's pageant will receive a crown, sash, trophy, flowers and a \$200 cash prize to help with the cost of attending the fair each day. She will be making appearances at multiple events with the 2023 Jr.Miss ,Little Miss Broome County Fair. **This year the Winners will be doing some Volunteering throughout the week at the fair.**

Applications should be returned by email or to the following address. Please contact me if you have any questions or if you decide that you are not going to do the pageant.

We will be holding a practice and meet and greet on Sunday the 23rd at the Broome County Fairgrounds Entertainment building starting at 6:00pm. This will be to let the girls meet each other and learn what they are going to have to do the day of the pageant. We will be picking the order in which you will be going.
